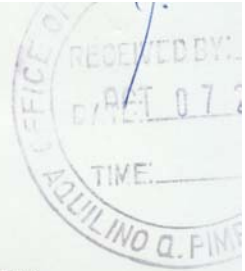



EXEMPTING FAMILY HOMES FROM REAL  
PROPERTY TAX SPONSORED BY HONORABLE  
SENATOR AQUILINO PIMETEL, JR.

WHEREAS, payment of real property tax imposes undue burden upon the family which is considered as the core unit of the society;

WHEREAS, the purpose of the family home is to provide shelter, which is a basic family need and the imposition of a real property tax on family home makes it difficult for many individuals to maintain a shelter for their families;

WHEREAS, in countless instances, the poor or financially hard up families default on the payment of real property tax which may cause threat of their homes;

WHEREAS, under Senate Bill 1135, the home of taxpayers will be exempt from real property taxes whose value do not exceed P3 million in urban areas and P2 million in rural areas;
